Dear Chairman Cole and Ranking Member DeLauro:

I am requesting funding for the City of Chandler Sewer Rehabilitation - Phase Two project in Fiscal Year 2027. The entity to receive funding for this project is the City of Chandler located at 175 S. Arizona Ave., Chandler, AZ 85225.

The funding would be used to support phase two of the project, which will repair, replace, and reline a separate group of the City's 7,000 manholes and 10 miles of sewer main lines within Chandler's collection system.

The project is an appropriate use of taxpayer funds because the project would help extend the life of the city's sewer and wastewater collection system; reduce risk of sewage overflows and related health and environment hazards; and reduce risk of emergency repair costs or service interruptions, ultimately saving taxpayer money over the long term.

The project has a federal nexus because the funding provided is for purposes authorized under Title VI of the Clean Water Act, 33 U.S.C 1381 et seq.
