I am requesting funding for City of Phoenix - Girasol Three Choice Neighborhoods Housing Redevelopment project in Fiscal Year 2027. The entity to receive funding for this project is the City of Phoenix, located at 200 West Washington Street, 12th Floor, Phoenix, AZ 85003.

The funding would be used for the new construction costs associated with building 140 new apartments as part of Girasol Three, the final multifamily phase of the City of Phoenix's Choice Neighborhoods (CN) Transformation Plan for the Edison Eastlake Community. The project is an appropriate use of taxpayer funds because the families of the Edison Eastlake neighborhood will benefit from expanded opportunity, improved amenities, and a revitalized community environment. This project directly addresses affordable housing needs in Phoenix, specifically targeting residents at 60% Area Median Income (AMI) or below. Completing the Girasol community will conclude the nine project, multi-phase strategy to revitalize the EEC into a high quality, mixed income neighborhood.

The project has a federal nexus because the funding provided is consistent with purposes authorized in 42 U.S.C.5305(a)(1), 5305(a)(2), 5305(a)(4), and/or 5305(a)(5).
