I am requesting funding for City of Tempe - Affordable Housing Development with Fire Station - Phase Two in Fiscal Year 2027. The entity to receive funding for this project is the City of Tempe, located at 3500 S. Rural Rd., Suite 202, Tempe, AZ 85282.

The funding would be used for site-specific predevelopment construction activities, including demolition, environmental assessments, and archaeological activities to advance the affordable housing with co-located Fire Station 3 project at 950 E. Baseline Rd. The project is an appropriate use of taxpayer funds because the final project will serve low-income individuals and families earning up to 60% of AMI with affordable housing in a high-opportunity area of south Tempe to support economic mobility, reduce transportation cost burdens, and increase access to employment and community amenities. It supports Tempe's long-standing goals of housing affordability, economic inclusion, and equitable access to opportunity.

The project has a federal nexus because the funding provided is consistent with purposes authorized in 42 U.S.C.5305(a)(1), 5305(a)(2), 5305(a)(4), and/or 5305(a)(5).
